#### **Order of Business**

The regular meetings of the board of education begin at 5:30 p.m. in the Administration Office's Board Room on the second and fourth Tuesday of each month. (Closed sessions are scheduled prior to the 5:30 p.m. regular session.) Special meetings are convened on an as-needed basis.

#### **Estimated Time**

The time at which an item is scheduled is an estimate only. The board may consider and act on an agenda item in a different order or an item may be considered earlier or later than the estimated time. Additionally, discussion of agenda items may be postponed to a future meeting. All persons interested in an item listed on the agenda are advised to be present throughout the meeting to ensure that they are present when the item is called.

## **In-Person Public Comments**

The Board of Education encourages public comment on the items for action on this Regular Board Meeting agenda and all other items related to the District. Speaker cards may be turned in at any time before an agenda item is called. When addressing the Board, please use the microphone and state your name. Individual speakers are generally allowed three minutes to address the Board, however, the time may be reduced by the Board president. When a speaker wishes to comment on multiple items, his/her time may be limited so as not to interfere with the timely completion of the board's business, and in no event shall a speaker be allowed to speak to more than three items at a single meeting. The total time allowed for public comment on any one item is 20 minutes, if

There is a separate opportunity at the opening of the meeting for public comments on the consent agenda, other listed agenda topics, and on other matters not on the agenda but under the jurisdiction of the board. Since items on the Consent Agenda are considered in a single board action, comments from a single speaker on multiple items on the Consent Agenda are limited to a total of three minutes. The board of education is not responsible for the content of statements made during public comment.

#### **Remote Public Comment**

Any individual wishing to address the Board remotely must register to speak using the **Speaker Sign Up Form** by **12pm** on the day of the meeting.

When persons are called on to speak, their microphone will be activated by District staff and the speaker will be notified that they can now unmute themselves in order to begin speaking. The speaker will then need to unmute themselves by selecting the 'mute/unmute' icon. Please state your name at the beginning of your comment.

If joining by phone, their microphone will be activated by District staff and the speaker will be notified that they can now unmute themselves in order to begin speaking. The speaker will then need to unmute themselves by dialing \*6. Please state your name at the beginning of your comment.
