### UNIFORM COMPLAINT PROCEDURES <u>BP1312.3</u> (click to view full policy)

The Uniform Complaint Procedures apply to the filing, investigation and resolution of complaints regarding alleged:

1) failure to comply with federal or state law or regulations governing adult education, consolidated categorical aid programs, migrant education, vocational education, child care and developmental programs, child nutrition programs and special education programs;

2) unlawful discrimination against any protected group as identified under Education Code (EC) sections 200 and 220 and Government Code section 11135, including actual or perceived sex, sexual orientation, gender, ethnic group identification, race, ancestry, national origin, religion, color, or mental or physical disability, or age, or on the basis of a person's association with a person or group with one or more of these actual or perceived characteristics, lactation accommodations, homeless, foster youth, juvenile court student, physical education minutes, or non-instructional courses, in any program or activity conducted by a local agency, which is funded directly by, or that receives or benefits from any state financial assistance;

3) failure to comply with school safety planning requirements as specified in Section 7114 of Title 20 of the United States Code;

4) unlawful discrimination, harassment, intimidation, and bullying based on actual or perceived characteristics set forth in Section 422.55 of the Penal Code and EC 220, and disability, gender, gender identity, gender expression, nationality, race or ethnicity, religion, sexual orientation, or association with a person or group with one or more of these actual or perceived characteristics; and

5) unlawful imposition of pupil fees for participation in educational activities in public schools; and 6) failure to comply with the requirements established through the Local Control Funding Formula related to the Local Control and Accountability Plan as described in EC sections 52060 through 52076 or sections 47606.5 and 47607.3. A complaint must be filed no later than six months from the date the complainant first obtains knowledge of the concern. These uniform procedures require the complainant to submit a written complaint to the Santa Barbara Unified School District's Assistant Superintendent of Human Resources, or the Assistant Superintendent of Education, or the Assistant Superintendent of Student Services who will coordinate an investigation and response within 60 days of receipt of the written complaint, unless the complainant agrees in writing to extend the timeline. If the District finds merit in a complaint, the District shall provide a remedy to all affected pupils, parents/guardians. A complainant may appeal the District's decision to the California Department of Education (CDE) by filing a written appeal within 15 days after receiving the District's decision. The CDE may directly intervene in the complaint without waiting for action by the district when one of the conditions listed in Section 4650 of Title 5 of the California Code of Regulations exists, including cases in which the district has not taken action within 60 days of the date the complaint was filed with the district. If a district is found to have violated a State or Federal law and/or regulation, and the District does not take corrective action to comply, then various civil remedies may be available. [Title 5 California Code of Regulations 4622; Education Code 234.1, 32289, 49013; Board Policy 1312.3]

## SEXUAL HARASSMENT POLICY <u>BP5145.7</u> (click to view full policy)

The Governing Board is committed to maintaining a safe school environment that is free from harassment and discrimination. The Board prohibits sexual harassment targeted at any student by anyone at school or at school-sponsored or school-related activities. The Board also prohibits retaliatory behavior or action against any person who reports, files a complaint or testifies about, or otherwise supports a complainant in alleging sexual harassment. The district strongly encourages any student who feels that he/she is being or has been sexually harassed on school grounds or at a school-sponsored or school-related activity by another student or an adult who has experienced off-campus sexual harassment that has a continuing effect on campus to immediately contact his/her teacher, the principal, or any other available school employee. Any employee who receives a report or observes an incident of sexual harassment shall notify the principal or a district compliance officer without delay. Once notified, the principal or compliance officer shall take the steps to investigate and address the allegation, as specified in the accompanying administrative regulation.

# ADD/DROP POLICY

Per SBUnified Administrative Regulation 5121, A student who drops a course during the first six weeks of the semester at Santa Barbara High School and Dos Pueblos High School and during the first three weeks at San Marcos High School may do so without any entry on his/her permanent record card. A student who drops a course after the first six weeks shall receive WF grade on his/her permanent record, unless otherwise decided by the principal or designee because of extenuating circumstances. (Under the block schedule, all timelines will align with the three week drop deadline).

# **COMMUNITY SERVICE**

Sixty hours of community service are required to graduate. Community service forms and a list of approved organizations must be obtained in the Career Center or downloaded from the website prior to participation. Community Service must be turned in <u>each year</u> for that year's activities.

# PE DRESS CODE PROTOCOL

Students shall: Dress appropriately and in accordance with established guidelines.

Consequences for infraction: Each infraction includes loss of points (see teacher syllabus) plus the following:

<u>1st Offense</u>: Teacher gives a verbal warning and helps student resolve non-dress issue (loaner clothes, etc.) <u>2nd Offense</u>: Teacher assigns a detention and notifies parent/guardian via phone call/email. <u>3rd Offense</u>: Teacher refers student to the IC for the period and notifies parent/guardian via phone call/email.

<u>4th Offense</u>: Teacher refers student to the IC for two periods, and notifies the student's grade-level Administrator (include dates of non-dress, dates of notifications to parent, first date of referral to IC) <u>Subsequent Offenses</u>: Consequences set by the Administrator (possible Saturday School) and parent may

attend class

All ambitious students are encouraged to try out for any one of the numerous athletic teams. Qualifications for these are:

- 1. Passing a physical examination given before participation in a sport.
- 2. Meeting citizenship and scholastic achievement criteria and completing 25 units per semester.
- 3. Having adequate insurance and parental consent.

# ELIGIBILITY REQUIREMENTS

### Citizenship

To participate, a student's citizenship needs to be satisfactory and follow the guidelines as set out by the athlete's code of conduct.

### Drugs, alcohol, tobacco and controlled substance

A student involved in the possession, use, sale or provision of drug paraphernalia, drugs, alcohol, tobacco or other controlled substances, as defined in the Health and Safety Code Section 11007, will be suspended (Santa Barbara High School District Administrative Regulation 5114).

**First Offense:** Students will be suspended from all co-curricular activities/athletics for 14 days from the day of the incident. Students may return to their co-curricular activity/athletics after two weeks. Student-athletes will be referred to the Family Service Agency for an intake to assess any drug/alcohol/tobacco dependency issues and may decide to provide student-athlete with an agency referral for further services. Any exceptions to this policy may be appealed to the Site Administrator.

Second Offense: Removal from all sports teams for the remainder of the school year.

### Athletic Eligibility

In order to represent a Santa Barbara District high school in athletics, a student must have earned an unweighted grade point average of 2.0 or higher in the quarter immediately preceding that of participation (Santa Barbara High School District Administrative Regulation 5170). In addition, a student must be making normal progress toward graduation by passing at least 25 semester units of new work the previous semester. Only one of the subjects may be physical education (Santa Barbara High School District Administrative Regulation 5170).

#### **SBUSD Code & Contract**

In order for students to participate on athletic teams, student and parent signatures will be required on the forms linked above.

# **COUNSELING SERVICES:**

### **COUNSELING APPOINTMENTS**

Drop by the Counseling Desk in the Administration Building during non-class time (before school, during lunch or after school) and make an appointment to see your counselor with the Counseling Office Assistant.

### DROPPING A CLASS, TRANSFERRING, WITHDRAWING

Students are given several opportunities before the beginning of each semester to review their course requests and make modifications to their requests by contacting their counselor. Once schedules have been distributed, opportunities to make program changes are limited and are subject to approval. The following summarizes important dates and deadlines:

#### **SEMESTER 1**

August 18, 2020: First day of school. Final schedules distributed.

August 19-20, 2020: New student scheduling. Changes for continuing students' schedules made for errors and omissions only. No student-initiated changes considered.

August 28, 2020: All petitions changes, if approved, will be made by the counselor and returned to the student.

<u>September 4, 2020:</u> Last day for schedule changes without penalty. After this day, a withdraw/fail (WF) will be noted on the transcript.

#### **SEMESTER 2**

December 8, 2020: New schedules for second semester verified (tentative date).

January 19, 2021: First day of second semester. Final schedules distributed.

January 20-21, 2021: New student scheduling. Changes for continuing students' schedules made for errors and omissions only. No student-initiated changes considered.

January 29, 2021: All petition changes if approved, will be made by the counselor and returned to the student.

<u>February 5, 2021</u>: Last day for schedule changes without penalty. After this day, a withdraw/fail (WF) will be noted on the transcript.

# **POLICIES:**

# ATTENDANCE

Attendance is required and it is the responsibility of the student and parent/guardian to meet this requirement. Attendance is recorded for each period. If you are ill, have your parents call the Attendance Office at (805) 284-9691.

The only valid legal excuses for an absence (<u>CA Education Code Section 46010</u>) or tardy from school are: illness; quarantine; medical, dental, optometrical, or chiropractic services; attendance at a funeral service of an immediate family member; jury duty; or exclusion from school because the child was not fully immunized. AN EXCUSED ABSENCE MUST BE CLEARED WITHIN THREE SCHOOL DAYS, OR THE ABSENCE WILL BE CONSIDERED A TRUANCY BY LAW. If a student needs to leave campus during school hours, they must get an off-campus permit from the attendance office BEFORE they leave campus. If a student leaves without permission, the absence will be recorded as a truancy.

If you miss school and your absence is unexcused you are legally considered truant. Your parent/guardian will receive written notification in the mail if you accumulate 12 or more period truancies. 24 or more period absences will result in a parent, student meeting with the Dean of Students. Any further absences will potentially result in a referral to the District Attorney's School Attendance Review Board for further consequences.

Students who are tardy five or more times to a class period will be assigned a lunch detention. Students who receive one to four truancies total will be assigned a detention by an administrator, and if they are truant five or more times they will be assigned a Saturday Detention. Should a student fail to serve assigned detention, an administrator will assign an additional consequence. No-shows may result in a doubling of the detention, Saturday Detention, or more serious consequences.

Attendance is a prerequisite to a good education and must be a primary concern of students, parents and school personnel at all times. Thank you for your cooperation.

# DISCIPLINE

Teachers will make every effort to implement classroom-based interventions and apply restorative practices to student behavior infractions. If teacher-led interventions are not successful, teachers will enter an administrative referral to the grade-level administrator and/or the Dean of Students, and behavior will be documented in the student's record on Aeries. School administration will make every effort to engage in restorative and educational

recourse as a way to use the behavior infraction as a learning opportunity rather than solely punitive. Should a student deny and/or refuse any restorative options offered, traditional discipline will occur.

### EDUCATION CODE 48908 - DUTIES OF PUPILS

All pupils shall comply with the regulations, pursue the required course of study, and submit to the authority of the teachers of the schools.

A student may be disciplined, suspended or expelled for any of the acts listed below if the act occurs while on school grounds, while going to or coming from school, during the lunch period (on or off campus), or during, going to, or coming from any school-sponsored activity at any school or on any school district's grounds. Education Code 48900(r). (References in the "Offense" column below: **EC** is Education Code; **SBUSD BP** is Santa Barbara Unified School District Board Policy.) (See <u>Note 7</u> below, for specific examples of "other means of correction.")

#### Note:

1. With the exception of the use of personal electronic devices for academic purposes as directed by school staff members, such devices must be turned off from the first bell until dismissal (end of school day). The administration is not responsible for the loss or theft of personal items.

2. Education Code 48903 provides for the recommendation for expulsion or involuntary transfer to another school site any student who has accumulated 20 days of suspension (or 30 days if already transferred to another school for adjustment purposes).

3. Education Code 48900S provides that these disciplinary guidelines apply to students on any school campus (in or out of district) and that a pupil may be suspended or expelled for acts that are enumerated in this section and related to school activity or attendance that occur at any time, including, but not limited to, any of the following: (1) while on school grounds, (2) while going to or coming from school, (3) during the lunch period whether on or off the campus, (4) during, or while going to or coming from, a school sponsored activity.

4. Board Policy 5145.12 provides general guidance with regards to student searches. In all cases, school officials will not conduct a search absent reasonable suspicion.

5. Misuse of electronic devices (e.g., computers, cell phones, PDAs) can result in additional legal and school consequences. Misuse of electronic devices, regardless of time and place, that disrupt the educational environment will also result in application of these disciplinary rules.

6. All school lockers and all of their contents are subject to search. Students are advised not to share lockers: Unauthorized contents of a locker are presumed to belong to the student assigned to it.

- 7. Other means of correction include, but are not limited to, the following: <u>Back to Top of Discipline</u>
  - a. A restorative conference between school personnel, the pupil's parent or guardian, and the pupil.
  - b. Referrals to the school counselor, psychologist, social worker, child welfare attendance personnel, or other school support services personnel for case management and counseling.
  - C. Student study teams, counseling teams, resource panel teams, or other intervention-related teams that assess the behavior, and develop and implement individualized plans to address the behavior in partnership with the pupil and his or her parents.
  - d. Referral for a comprehensive psychosocial or psychoeducational assessment, including for purposes of creating an individualized education program, or a plan adopted pursuant to Section 504 of the federal Rehabilitation Act of 1973 (29 U.S.C. Sec. 794(a)).
  - e. Enrollment in a program for teaching prosocial behavior or anger management.
  - f. Participation in restorative approaches including Restorative Conferencing, Reactive Peace Circles, Intentional Reintegration after suspension.
  - g. A positive behavior support approach with tiered interventions that occur during the school day on campus.
  - h. After-school programs that address specific behavioral issue or expose pupils to positive activities and behaviors, including,
  - but not limited to, those operated in collaboration with local parent and community groups (e.g.-Teen Court and SUPER).
  - i. Any of the alternatives described in Section 48900.6.

If a student is referred to the administration for disruptive behavior and/or disciplinary action, he/she may be placed on an administrative contract and parents or guardians are notified. If similar behavior occurs again, the student may be suspended or recommended for expulsion. The current <u>SBUSD High School Information Handbook and Course</u> <u>Catalog</u> specifically outlines the disciplinary action taken for specific offenses listed in the above table.

### DRESS CODE

The Santa Barbara Unified School District is committed to establishing a safe and secure learning environment. While a student's attire is generally at the discretion of a parent/guardian, appropriate dress standards are necessary for the healthy, safe and undisrupted operation of a school.

#### Appropriate Dress Standards

Our district's students are prohibited from wearing clothing that (a) causes an actual distraction from or disturbance of any school activity, or interferes with participation of a student in a school activity, (b) creates a health or safety hazard or (c) impedes the learning of self or others.

## **POSITIVE BEHAVIOR INTERVENTION AND SUPPORTS**

We abide by the motto, "We ARE DP" and hold the Charger values of being Accepting, Responsible, and Engaged and expect our students to uphold these in the classroom, on campus, in our school community, at school related events, and online. # PERMITS TO LEAVE SCHOOL GROUNDS

Lunch Passes: Juniors and Seniors ONLY, if you leave at lunch, you must have permission to do so on file in the office (permission may be granted by parents/guardians electronically via the <u>DPHS Welcome Packet</u>) and you must be carrying an official off-campus permit/sticker on your ID Card. Pick up your "Free Period" application with your counselor in the main office and return the signed form to Ms. Rodriguez, located in the Administration Building. Disclaimer: Due to COVID-19 safety and screening protocols, our DP campus will be closed during the school days. Therefore, juniors and seniors will not be allowed to leave campus for lunch or free periods. We will be sure to keep you and your student updated as our situation evolves.

### UNAUTHORIZED ARTICLES

Any electronic device that interrupts class or any educational program will be confiscated.

# **VISITORS ON CAMPUS**

Anyone who visits Dos Pueblos High School must stop at the Administration Building and receive a guest pass from an administrator. The campus is NOT open to visitors during the school day unless prior arrangements for academic reasons have been made at least 24 hours in advance. Students cannot bring younger children they are

babysitting to school. All visitors on campus must complete the COVID-19 screening and temperature check upon arrival.

# WHEELED VEHICLES

### MOTORCYCLES • MOPEDS • BICYCLES • ROLLER SKATES • SKATEBOARDS

Students may park their vehicles on school property only in areas designated for student parking. The standard rules of proper use of an automobile will apply at all times. Students who endanger others by improper use of their vehicles will be denied parking privileges. NO STUDENT IS TO USE THE AREAS SET ASIDE FOR FACULTY PARKING OR VISITOR PARKING. DESIGNATED STUDENT PARKING IS IN THE LOT ADJACENT TO THE TENNIS COURTS.

Bicycles must be parked in a bike rack area. The riding of bicycles, motorcycles, mopeds, roller skates and/or skateboards, etc is NOT allowed on campus. # STUDENT COMMUNICATION

School information is regularly posted on the DP website at <u>www.dphs.org</u> in addition to being sent out via ParentSquare and StudentSquare. Parents and students are encouraged to check the site and their emails frequently. Each day the school also posts an electronic copy of the daily bulletin which you can find on the website and on NEO (DP's student information system). Students may submit an announcement with the appropriate faculty signature. Publication of the announcement is at the discretion of the administration. The bulletin announcements and other campus news and features are broadcasted to students three times a week in period 3 by our student-produced DP News program. Informational emails are sent to students and parents through Naviance and NEO.

# **TEXTBOOKS**

When a student is issued textbooks or any school-owned instructional materials by a teacher, the student is responsible for their safekeeping and timely return.
